1.0 Call to Order

Committee Chair Ross Patronsky called the meeting to order at 2:05 p.m.

2.0 Agenda Changes and Announcements

Chairman Patronsky stated that Mr. Buehler, the county representative, is retiring effective the end of May and that his replacement on the CMAQ Project Selection Committee will be Chris Snyder from DuPage County. The committee thanked Mr. Buehler for all his hard work and wished him luck.

3.0 Approval of Minutes—March 13, 2012

On a motion by Mr. Buehler and a second by Mr. Carmitchel, the minutes of the March 13, 2012 meeting were approved as presented.

4.0 Project Changes

4.1 On a motion by Mayor Keller and seconded by Mr. Rogers the committee approved a scope change and cost increase of \$22,400,000 total (\$14,560,000 federal) for a total project cost of \$33,600,000 total (\$21,840,000 federal) for Berkeley - Union Pacific Proviso Railyard Switcher Engine Retrofit (TIP ID 04-09-0002).

- 4.2 On a motion by Mr. Buehler and second by Mr. Carmitchel the committee approved the scope change to IEPA Chicago Area Diesel Retrofit Program (TIP ID 13-09-0003) to allow IEPA to administer 100% funding to private school bus operators to install particulate filters.
- 4.3 On a motion by Mr. Rogers and second by Mr. Pitstick the committee approved a cost increase to \$4,100,000 total (\$3,280,000 federal) for IEPA Retrofit of Amtrak Switcher Engines (TIP ID 01-09-0006), retaining the 20% local match requirement.
- 4.4 On a motion by Mr. Buehler and second by Mr. Privett the committee approved the scope and cost change for Aurora McCoy Dr/Commons Dr from Gregory St/New York St to IL 59/US34 (TIP ID 09-12-0012) to include a signal at Commons Drive and Liberty Street and an increase of \$230,469 (\$184,375 federal) for a total project cost of \$1,152,375 (\$921,875 federal).
- 4.5 On a motion by Mr. Privett and second by Mayor Keller the committee approved the cost increase for Elgin Bikeway Plan Route 1 NE Quadrant (TIP ID 09-09-0006) for a cost increase of \$164,000 total (\$131,200 federal) for a total project cost of \$586,750 total (\$469,400 federal).

5.0 Program Monitoring

- 5.1 Ms. Ostdick referred to a memo included in the packet and summarized the procedure being described. CMAP staff, IDOT staff and planning liaisons worked together to develop the proposal. Questions were raised about the use of tiered percentages, a minimum dollar amount regardless of percentage and contract award amount. Ms. Ostdick stated that the tiered percentages are flexible and that staff does not currently collect the contract award amount. On a motion by Mr. Buehler and second by Mr. Carmitchel the committee approved the procedure with the following revisions: 5% of the authorized amount will be retained regardless of award amount and a minimum of \$100,000 will be kept with the project.
- 5.2 Mr. Ferguson stated that a project line item by year report was included in the packet and that an updated report with changes highlighted will be added as a standing agenda item at subsequent Project Selection Committee meetings. The committee requested that financial mark and unprogrammed balance information be included. Staff concurred.
- 5.3 Mr. Ferguson reported on the results of the 3rd and 4th Quarter 2011 Transit expenditure reports. He clarified that the projects in these reports have been obligated through an FTA grant; the report tracks the expenditure of funds obligated in those grants.

6.0 GO TO 2040 Focused Programming Approach Lessons Learned

Mr. Ferguson reviewed the report included in the meeting materials and the recommendations for the next call for projects. On a motion by Mr. Buehler and second by Mr. Privett the committee approved the recommendations.

7.0 Post-Implementation Evaluation of Emissions Benefits of CMAQ Projects

Mr. Patronsky stated the final report is included in the packet. He noted that staff would be meeting with the report author to see if she had any recommendations for improvements to the bicycle/pedestrian analysis methods.

- **8.0** Other Business There was no other business.
- **9.0 Public Comment** There was no public comment.
- 10.0 Next Meeting The committee's next meeting is scheduled for May 24, 2012.

Re: CMAQ Project Change Requests

5 projects have been submitted for changes. The net change in the federal CMAQ amount programmed for Federal Fiscal Year 2012 is \$3,164,304 total (\$7,075,019 federal). The sponsors' requests are attached.

For Committee Consideration:

Riverdale – CSXT Barr Rail Yard Switch Engine Retrofit (TIP ID 07-08-0010)

The sponsor is requesting a scope change to purchase 4 single-engine Tier 3 locomotives instead of multi-engine GenSets switchers. The sponsor has indicated that there are maintenance concerns with the multi-engine GenSets. The cost of the project is unchanged at \$ 6,000,000 total (\$3,900,000 federal).

Recommendation to the CMAQ Project Selection Committee:

Consider approval of the scope change from multi-engine GenSets to single engine Tier 3 switcher locomotives.

Pace - Transit Diesel Engine Retrofits 2012-2016 (TIP ID 17-12-0003)

The sponsor is requesting a scope change to purchase US EPA-certified retrofit technology instead of the Syngas diesel particulate filter (DPF) technology identified in the application. The company that was making the technology that was to be used by the sponsor has gone into receivership and the technology is no longer available. The sponsor is now requesting to replace 2006 model year engines with upgraded 2007 model year engines and install DPFs with diesel oxidation catalysts. The sponsor has indicated that the 2007 engine, while not the latest model available is the latest model that can be installed without significant and very expensive structural changes to the vehicles. A re-ranking was completed which took into account the technology being requested in the scope change and the project ranking was unchanged among Diesel Reduction projects in the 2012-2016 program. The cost of the project also remained the same at \$10,500,000 total (\$8,400,000 federal).

Recommendation to the CMAQ Project Selection Committee:

Consider approval of the scope change to allow Pace to purchase US EPA-certified retrofit technology instead experimental technology identified in their CMAQ application.

RTA – Regional Transit Signal Priority Integration Plan, Five Year Implementation: Priority Corridors (TIP ID 13-12-0002)

RTA – Chicagoland Commute Options (TIP ID 13-12-0004)

RTA – Improvements at 19 Priority Interagency Transit Transfer Locations (TIP ID 13-12-0005)

The sponsor is requesting an increase from 80% to 90% the federal share for the project conditionally based upon the approval of the revised Programming and Management Policies by the MPO Policy Committee at their June meeting.

Recommendation to the CMAQ Project Selection Committee:

Consider approval to increase from 80% to 90% the federal share for the projects listed above, conditionally based upon the approval of the revised Programming and Management Policies by MPO Policy Committee.

Schaumburg – Schaumburg-Schaumburg and Barrington Roads Intersection Improvements (TIP ID 03-00-0108)

The sponsor is requesting a cost increase in the amount of \$3,164,304 (\$2,531,443 federal). The cost increase is due to project design requirements and inflation. This project also has STP-L, IDOT, Cook County, and Local funds. The project is currently in the final design phase with final plans submitted to IDOT for review and anticipates a November 2012 letting.

The proposed increase in CMAQ funding would bring the CMAQ funded portion of this project to \$5,770,054 total (\$4,616,043 Federal). A re-ranking was completed and the project went from 8th to 12th among 2006 intersection improvement proposals which dropped the project below 4 proposals that did not receive funding that year.

Recommendation to the CMAQ Project Selection Committee:

Consider approval of the cost change of \$3,164,304 (\$2,531,443 federal) for a total CMAQ project cost of \$5,770,054 total (\$4,616,043 Federal).

Berkeley - Union Pacific Proviso Railyard Switcher Engine Retrofit (TIP ID 04-09-0002)

The sponsor is requesting a scope change that would allow the sponsor to consider Tier 3 certified low-emitting switch locomotives as well as GenSet locomotive when soliciting bids. The sponsor was approved at the April 5, 2012 meeting for the additional purchase of 14 GenSet locomotives. They would like the flexibility when soliciting bids to increase the competitiveness of bids from greater number of vendors, increase the functionality of the switchers, increase reliability of switchers and help maintenance issues. The cost of the project is unchanged at \$ 22,400,000 total (\$14,560,000 federal).

Recommendation to the CMAQ Project Selection Committee:

Consider approval of the scope change to include Tier 3 switcher locomotives for potential use by the project.

Administrative Modifications:

Dear Mr. Patronsky,

In January 2009, CSX Transportation, Inc. (CSXT) submitted a CMAQ application requesting funding towards the repower of four conventional diesel switcher locomotives with non-road based generator set (genset) technology. The proposal has since been accepted and the agreement is currently being prepared for signature/approvals.

By this letter, CSXT is specifically requesting to modify the project from multi-engine to single-engine genset locomotive configurations. Since the time of the original application, CSXT has been evaluating the availability of single-engine genset switcher locomotive platforms and currently there are several manufacturers that are offering them with EPA Tier 3 line-haul certification. CSXT is engaged in discussions with EMD, Caterpillar, and MTU to determine engine performance and availability. Upon your approval and execution of the contract, CSXT will conduct a competitive procurement to select the project vendor.

A contributing factor to this request is that CSXT has undertaken several multi-engine repowers, and we are experiencing issues with service availability and performance in several locations due to the increased maintenance requirements of the multi-engine technology. Although there are fuel savings, these savings are somewhat offset by increased maintenance intervals and associated costs of the high-speed non-road certified engines. Also, the transition of our maintenance program and personnel from a medium-speed (900 rpm) single-engine fleet to one that includes limited numbers of high-speed (1800 rpm) multi-engine units has uncovered concerns regarding implementation of the multi-engine units. As an example, CSXT mechanics are highly trained with respect to medium-speed engines

and the current internal maintenance, as well as Federal Railroad Administration (FRA) required maintenance intervals, which are not consistent between multi-engine and single-engine locomotives. Specifically, the single-engine locomotives are designed to conform to the FRA 92-day maintenance and inspection intervals. However, because the multi-engine units require more frequent maintenance intervals, they are not available to cover CSXT's operational requirements as often.

By repowering with a single-engine unit, CSXT will be able to achieve emission reductions near to those for a multi-engine unit and will be able to continue with existing maintenance intervals. One of the preferred options available for a single-engine genset employs an EMD 8-710 engine; CSXT has a significant number of EMD-powered locomotives in the fleet. Repowering with a single-engine configuration would allow for streamlined transition for the operations and maintenance personnel (e.g., similar operating characteristics, maintenance requirements) from the older pre-emission regulation to the current state-of-the-art EPA certified locomotives.

In summary, CSXT would like your concurrence with substituting the single engine technology on this project. After you have had the opportunity to review, please let me know if you have any questions or comments.

Holly:

As a part of Pace's continuing efforts to reduce emissions and improve fuel economy, Pace had selected an emerging technology to be an important part of the improvements requested in the FY 2012-2016 CMAQ program applications. Pace had chosen to have a Syngas generator which was developed by NextGen to be installed along with an improved emission after treatment system. During the course of developing this project the company which owned the rights to the technology lost their financial backing and eventually went into receivership. As a result the device referred to as a Syngas generator is not available as part of an approved emissions device for this project. The original proposal we were retrofitting the existing engines with improved mechanical components and syngas DPF. Our intent was to add the syngas DPF at time of midlife engine replacement.

As a result, Pace proposes a revision to our original program with a revised proposal to replace the current vehicle engine with an upgraded model, engine electronic control programing and installing a Diesel Particulate Filter with Diesel Oxidation Catalyst. Pace plans to replace the current 2006 model year engines with upgraded 2007 model year. While the 2007 is not the latest model available it is the latest that we can install in the bus without significant and very expensive structural changes to the vehicle.

This is most effective treatment to reduce the bus emissions we have been able to develop since the syngas DPF has been removed from the market. This change will reduce NOx exhaust emissions and increase fuel economy reducing NOx emissions from 2.5g/hp-hr to 1.2g/hp-hr.

Pace is requesting approval for this change on the three project years within the current FY 2012–2016 program. We estimate the new proposal can be accomplished within the same cost of the original scope with no reduction in the number of buses. Our grant submittal with FTA is pending approval of this scope revision.

The Village of Schaumburg is the lead agency on the proposed improvements at the intersection of Barrington Road and Schaumburg Road. The average daily traffic projected to use this intersection in the year 2030 exceeds 80,000 vehicles per day, while the total length of this intersection improvement exceeds one mile. This project will reduce congestion, improve air quality, and provide a significant improvement in safety.

Barrington Road is a State Strategic Regional Arterial Route and Schaumburg Road is a Cook County major arterial. This project is currently in the final design phase with the final plans submitted to the State for final review. The Right-of-Way Acquisition is proceeding on schedule. Since this project has Quick-Take ability, it is anticipated that this project can meet a November 2012 State letting. The project estimate for construction and construction phase services is \$8,959,855. Currently, a total of \$2,084,600 CMAQ funds have been approved as well as the maximum \$4,000,000 of STP funds recently secured through the Northwest Municipal Conference. The State, Cook County, and the Village appreciate the support of this project from the NWMC and CMAP.

In order for the project to proceed to construction, the Village of Schaumburg, on behalf of the three agencies involved in this project, is requesting additional CMAQ funds in the amount of \$2,531,443. This amount represents the remaining amount eligible for CMAQ funding and will address increases in cost due to project design requirements and inflation. If approved, the CMAQ portion of this project would fund 42.7% of the total project costs. STP funds would fund 37% and the balance of the funding, 20.3% would be shared by the three agencies involved. The agencies involved in this project, the State of Illinois, Cook County Highway Department, and the Village of Schaumburg, are all in support of this project. Enclosed is a project funding spreadsheet, project funding timeline, and letters of support/intent.



The Department has received your letter dated December 16, 2011 regarding the locally initiated improvements along Schaumburg Road at Barrington Road in the Village of Schaumburg. We apologize for the delay in responding. We have reviewed your request for additional State financial participation and offer the following comments.

Our Department has previously committed to State financial participation in various preconstruction activities associated with this locally initiate improvement. In our initial Letter of Intent dated January 20, 2009, our Department committed to State financial participation in the non-federal portion of the Phase II Engineering associated with the State-owned legs of the intersection. This amount of State participation was \$35,000. On August 18, 2010 our Department amended the executed Letter of Intent to provide an additional \$145,000 in State financial participation in the non-federal portion of the Land Acquisition associated with the State-owned legs of the intersection.

Based on the cost table provided in your December 16, 2011 letter and the level of federal funds secured for this locally initiated project, our Department can consider additional State financial participation in the non-federal portion of the construction and construction engineering associated with the State-owned legs of the intersection. This State financial participation is limited to the level of federal funds secured for the locally initiated project. As indicated in previous correspondence, our Department is not in a position to provide additional funding for locally initiated projects to account for limitations in the availability of federal funds. The funding shortfall for the project is interpreted to be \$2,576,515 based on the following.

A review of the most recent fund table provided reveals that although the Department's initial Letter of Intent dated January 20, 2009 and amended Letter of Intent dated August 18, 2010 indicated that the State financial participation was for the non-federal portion of the Phase II Engineering and Land Acquisition associated with the State-owned legs of the intersection, the cost table indicates that State's financial participation was used to fund shortfalls in these costs beyond the 80% CMAQ and 20% matching funds. This use of State financial participation is not in the spirit of the interagency cooperation intended by our Department.

Based on the construction and construction engineering costs associated with the State-owned legs of the intersections as outlined in cost table provided, the following is the level of State financial participation that can be considered based on the current level of federal funds secured for the project (see attached table for details).

The above and the detailed table attached calculates the State's financial participation using a federal fund level of 70% based on STP funding through the Northwest Municipal Conference for construction, and assumes the remaining balance of CMAQ funding is utilized for the proposed traffic signal work using a federal fund level of 80%.

Our Department will consider this additional State financial participation should the Village of Schaumburg secure adequate federal funding so as not to require State financial participation to cover project funding shortfalls.

In response to a letter dated December 16, 2011 from the Village of Schaumburg, the Cook County Highway Department is willing to participate in proposed improvements for the subject intersection. Therefore, we have prepared this Letter of Understanding, in duplicate, to establish our mutual responsibilities for construction of the proposed improvements at the intersection of Schaumburg Road at Barrington Road for signature should you concur.

The general scope of work for this Intersection Improvement is to construct dual left turn lanes with center barrier median along all four legs of the subject intersection, including drainage improvements, combination curb and gutter, sidewalks and traffic signal modernization. The Village is currently conducting Phase II design engineering and right-of-way acquisition for this improvement under a previous Reimbursement Agreement with Cook County.

It is our understanding that the Village of Schaumburg has secured Congestion Mitigation and Air Quality (CMAQ) funding (\$2,084,600.00) and Surface Transportation Program (STP) funding (\$3,500,000.00) for use toward the Construction and Construction Engineering costs for the project. Further, the Illinois Department of Transportation has concurred to financial participation for the State's portion of the improvement. The County's financial participation will be limited to the nonfederal portion of construction costs associated with Schaumburg Road and is anticipated to be thirty (30%) percent of the local share of said costs, or an estimated County share of \$1,021,387.00. Based on the estimated costs for construction, and assuming construction engineering costs to be eleven (11%) percent of construction costs, the County's share of construction engineering costs are estimated as \$247,991.00. A funding distribution table dated 12/15/11 summarizes our respective cost obligations and is attached hereto as EXHIBIT A.

We will program funds for our share of the construction costs (estimated \$1,021,387.00) in our FY 2013 as part of our FY 12-16 Highway Improvement Plan currently being drafted.

The Village of Schaumburg agrees to continue to act as the lead agency for this improvement, including Phase II Design and Construction, and will continue to process this improvement through the Illinois Department of Transportation, Bureau of Local Roads and Streets, District One office.

Village improvements (street lighting, landscaping, emergency vehicle pre-emptive device, etc.) and Holmes Way improvements, including engineering, will be 100% Village cost responsibility.

As the Phase II design plans near completion, a formal Agreement will be prepared by the Highway Department to formalize our specific project costs, maintenance responsibilities and terms for reimbursement from Cook County to the Village of Schaumburg. The County share of construction costs will be split between contract award and project completion.

Please recall that the CMAQ PSC committee approved a scope change and cost increase of \$22,400,000 total (\$14,560,000 federal) for a total project cost of \$33,600,000 total (\$21,840,000 federal) for the Berkeley-Union Pacific Proviso Railyard Switcher Engine Retrofit project (TIP ID 04-09-0002) to utilize 14 low-emitting switch locomotives at our Dolton facility.

We are preparing to solicit bids from vendors and request permission to evaluate Tier 3 certified - technologies to satisfy the contractual obligations (as amended to include these additional locomotives). This scope change would allow us to consider GenSets and alternative low emissions technologies based upon emissions criteria.

This request is driven by our desire to (a) obtain competitive bids from a greater number of vendors, (b) to ensure we purchase switchers that have proven functional from an operations standpoint, (c) to deliver a reliable locomotive which utilizes components that are currently carried in inventory (avoids adding new items to stock), and, (d) to provide a product that is very similar to those our shop personnel are currently prepared to maintain (equipped, trained and experienced).








There is currently over \$180 million in unobligated CMAQ funds in the CMAP region. All of these funds were programmed for implemention on or before 2012. Funds are eligible for rescission and lapse by the federal government. To ensure these funds remain where they are sorely needed, the region needs to implement projects in a timely fashion. This report will explain where the largest balance of unspent funds are, describe reasons for delay, and give tips for accomplishment.

The chart below shows the total programmed by sponsor group, the amount accomplished, and the remaining unobligated balance. Municipalities, counties, park districts, and other local agencies are grouped by sub-regional council. The total bar is how much each sponsor group has received from the inception of the program through 2016. The light green is how much has been accomplished by a group. The dark green is how much of that sponsors funding is outstanding.


Each May and October, project sponsors provide status updates on projects with phases funded that year. Each sponsor that has not accomplished the phase in that year must give a general reason for delay. Below is a chart showing the reasons provided for delay in 2011.
