Will County DOH has requested a change in scope for the signal interconnect project on Weber Rd/Naperville Rd/Lily Cache Ln from W. Boughton Rd to W. Lockport/Airport Rd (TIP ID 12-03-0012).

The change is being requested because the Weber Road corridor has been impacted by unexpected growth. The northern limit of the project, Boughton Rd, would be shifted south to Lily Cache Ln and the southern limit, Airport Rd, would be shifted south to Division St. There would be no change in the total cost of the project or the CMAQ share of the funding. The project is scheduled for the July 2004 letting.

The northern portion of this project is proposed for a CMAQ-funded signal interconnect in the FY 2005 program. The applicant is Bolingbrook.

The projects emission benefits were reevaluated and there was a drop in VOC eliminated of 1.4166 tons as the revised ranking sheet indicates. This would place the project at \$21,738 per Ton of VOC eliminated with the project ranking remaining the same at 3rd among the 2003 signal interconnect proposed projects.

Forest Park – Des Plaines Ave at Harrison St, Wilcox St and Jackson Blvd (TIP ID 04-01-0003)

Forest Park has requested a cost increase for the intersection improvement project on Des Plaines Ave at Harrison St, Wilcox St and Jackson Blvd (TIP ID 04-01-0003).

After completing Phase I and II engineering the costs for construction have come in higher than original estimated by \$128,543. The increase request is for \$102,834 in federal funds. The construction estimate and construction engineering agreement has been approved by IDOT Local Roads and Streets and the project is scheduled for the July 30, 2004 letting.

The cost increase would raise the cost per ton of VOC eliminated to \$306,372 from the original amount of \$254,109 as the revised rank sheet shows. The rank of the project remains the same at 9th among the 2001 signal interconnect projects.

On January 29, 2001 the Village of Forest Park was approved for the Traffic Flow Improvements for Des Plaines Avenue from Harrison Street to Wilcox Street. Des Plaines Avenue is an unmarked State Route with traffic signals located at Harrison Street, the CTA Entrance and Jackson The project includes the modernization of these State maintained signals including the installation of a fiber optic interconnect to In addition to the traffic signal modernization, the aid in traffic flow. intersection of Jackson Boulevard and Des Plaines Avenue includes channelizing each of the four approaches. This work is within the scope of the original CMAQ application prepared in 2000.

The original estimate of cost for this project was a total of \$625,000 which included engineering services. The Federal share that was approved was \$500,000 making the local match \$125,000 for a total project cost of \$625,000. Currently Christopher B. Burke Engineering, Ltd. (CBBEL) has completed the Phase I and II Engineering through IDOT's Bureau of Local Roads. The project is scheduled for a July 30, 2004 letting. Upon review of the updated project construction cost estimate and Phase III Engineering Agreement the total estimate cost of the project is \$753,542.69. 80 % of this amount is \$603,000 or an additional \$103,000 from the originally approved \$500,000. IDOT Local Roads has verified and approved the current construction estimate and Phase III engineering agreement.

The Village of Forest Park is committed to this much needed community project and is requesting that an additional Federal Share of \$103,000 be approved for this project.

Sidewalks (TIP ID 08-00-0012)

This project was discussed at the February 23, 2004 meeting of the CMAQ Project Selection Committee. The discussion was in the context of pedestrian projects, and whether locations with particular characteristics (e.g., existing sidewalks on one side of the street) should be approved.

The Westmont project was approved in the FY 2000 program. As the project approached letting, it became apparent that the planned locations would not be feasible, due to resident opposition.

At that point, the Village requested a scope change to install sidewalks at other locations. The emissions benefits from the revised locations were equivalent to the original benefits, so the change was approved.

At the time this change was approved, the CMAQ Project Selection Committee was not consulted. The approved Westmont project was described as "Westmont—Miscellaneous Sidewalks" and staff brought scope changes to the Committee only as necessary. In this case, the change was deemed minor, and approved administratively.

Since that time, the practice has evolved. The Committee is now asked to approve more types of changes, and is informed of all changes to scope or cost. With this change, the confusion that occurred in this case is unlikely to recur.
