5.1 IDOT – IL 59/Sutton Rd at Stearns Rd (TIP ID 03-12-0004) The sponsor is requesting a cost increase of \$1,189,000 federal (\$1,486,000 total) for construction in FFY 2017. ACTION REQUESTED: Approval of the requested cost increase.

5.2 IDOT – Cumberland Circle Improvement at Golf Rd/State St/Wolf Rd/Broadway St (TIP ID 03-14-0004)

The sponsor is requesting a cost increase of \$12,000 federal (\$15,000 total) for right of way in FFY 2016 and a reinstatement of construction funds in FFY 2017. The project has demonstrated readiness.

ACTION REQUESTED: Approval of the requested cost increase and reinstatement.

5.3 Mount Prospect – Covered Bicycle Parking at the Mount Prospect Metra Stations (TIP ID 03-16-0016)

The sponsor is requesting a schedule change to reprogram construction funds from FFY 2019 to FFY 2017 and a cost increase of \$16,400 federal (\$20,500 total) for construction in FFY 2017. ACTION REQUESTED: Approval of the requested schedule change and cost increase.

5.4 IDOT – I-90 from Cumberland Av to Harlem Av (TIP ID 03-96-0004)

The sponsor is requesting a cost increase \$6,093,000 federal (\$1,643,000 total) for construction in FFY 2016. ACTION REQUESTED: Approval of the requested cost increase.

5.5 IDOT – Wolf Rd from 153rd St to 159th St (TIP ID 06-16-0001)

The sponsor is requesting a schedule change to reprogram construction funds from FFY 2018 to FFY 2017. ACTION REQUESTED: Approval of the requested schedule change.

5.6 Carpentersville – IL 31 at Huntley Rd (TIP ID 09-08-0005)

The sponsor is requesting a reinstatement of funds and a cost increase of \$2,604,200 federal (\$3,255,250 total) for construction in FFY 2017.

5.9 IDOT – Edens Expressway/I-94 Bus on Shoulder (TIP ID 15-16-0004)

The sponsor is requesting a schedule change to reprogram construction and implementation funds from FFY 2018 to FFY 2017.

5.10 Lake County Forest Preserve District – Lyons Woods Bike Path (TIP ID 10-16-0007)
