

2018 CMAP Pavement Management Plan Call for Projects

Program Guide

The Chicago Metropolitan Agency for Planning (CMAP) announces the availability of technical assistance to complete Pavement Management Plans for local units of government throughout the region.

As part of efforts to help local governments achieve better pavement condition at reduced cost, a pilot program is being established to offer engineering services that will either develop or update a local pavement management plan. An engineering firm selected through a procurement by CMAP will provide the necessary services to complete a pavement management plan (PMP), which will provide the public agency a document that describes the importance and types of pavement preservation, the current condition of pavement, scenarios evaluating the cost to meet different network level pavement conditions, and develop a capital plan based on the selected pavement condition/spending scenario. The PMP will help communicate to decision makers and the public the importance of pavement preservation and what pavement improvement projects to implement that will be the most cost effective to meet certain pavement condition targets.

Eligible Applicants

Any local agency that maintains roads or programs federal funds towards the improvement of roads in the CMAP region. This includes municipalities, counties, townships, councils of government (COGs)/municipal associations, and groups of two or more municipalities.

Eligible Projects

The only eligible projects will be the initiating or updating of a Pavement Management Plan.

Local Match and Local Commitment

CMAP will be hiring the service providers (engineering consultants) through the CMAP procurement process and there will be no required match from selected participants. Selected participants should be committed to working directly with the consultants on a day-to-day basis and be responsive to their requests for information.

Project Evaluation and Selection Process

This program will be competitive and is expected to receive more project applications than can be accommodated in the 2018 Program. Each application will be reviewed and selected based upon:

- The ability of the applicant(s) to implement the pavement management plan
- Geographic equity throughout the region
- Need of the applicant(s)

During the review process, CMAP staff will contact each applicant to ask questions regarding the details of the proposed project. Project acceptance is dependent on funding availability.
